Superintendent Message

Welcome to the 2024-2025 school year! We are excited to see all students back on campus in a few weeks. Throughout this edition of the Eagle Insider you will find valuable information as you gear up for the first day of school on Monday, August 26th.

Please be sure to complete all re-enrollment paperwork that was sent to parents/guardians in July. It is important for us to have up to date information in our student information management system to begin the school year.

I want to share with you the three goals our board of education has set for the district. I am appreciative of the work our board of education does to help make Kent City Community Schools the amazing district it is. First, the board of education has asked that we raise our student achievement. This is the perfect place to start because it puts the focus on our students! We take pride in providing our students with a quality education. Our first rate educators go above and beyond to give all students the opportunity to make the most of their experience while at KCCS. I was told often by my former boss that "the product of our district is the achievement of our students." To help all students achieve their very best we will continue to focus our efforts on providing a content rich curriculum with research based best practices in teaching. This will give our students a foundation to be successful in life after they graduate from Kent City Community Schools. Whether that next step is college or career, a content rich curriculum partnered with research based best practices in teaching will allow our students to be ready for whatever lies ahead.


The next goal from the board of education revolves around increasing student mental health support. Unfortunately, we have noticed an increase in the number of student mental health incidents. To achieve this we have partnered with two different community based organizations. Last school year we worked with Arbor Circle to place a full time social worker in our district to provide year round support for students and their families. As we continue our work with Arbor Circle we will also begin a partnership with Family Health Care to utilize the Expanding, Enhancing Emotional Health program (E3 program) through the state of Michigan. The E3 program will provide another full time, year round therapist to work with students and families. Funded by a state grant, the E3 program has nearly all of its costs covered.

The third and final goal is to continue the strong financial footing our district currently has in place. As a Michigan public school system our budget is greatly affected by the budget set by our lawmakers in Lansing. We have been intentional to make financial decisions that include doing what is best for students and staff while making sure to focus on maintaining an appropriate fund balance. This year's budget from the state presents us with some challenges in certain areas. For example, the state has cut funding for school safety and student mental health from \$230 per student during the 2023/2024 school year to less than \$25 per student in the 2024/2025 school year. Our team created a budget for the 2024/2025 fiscal year that continues all school safety and mental health support for our students. This will cause us to dip into our fund balance, but still allows us to provide as much support as we can for the students of KCCS.

As we finish another wonderful Michigan summer, I hope that you are just as excited as we are to start this school year. Because of this community and the students we serve, we know that everyday is A GREAT Day To Be An Eagle!

Adverse weather conditions and other emergency situations may make it necessary to cancel school, to delay the beginning of school, or to send students home early. Our Superintendent and transportation department is out early in the morning to check road conditions. They are in contact with neighboring school districts. The final decision is made by the superintendent. Whenever it is necessary to delay or close school, notice will be communicated through TV channels 8, 13 and 17, the district & building Facebook pages, and the district website www.kentcityschools.org.

In the event of a two hour delay:

- * There will be no a.m. preschool.
- Buses will pick up students two hours later than normal.
- All classes will start two hours later than normal.
- No morning breakfast will be served.
- No 1st Session KCTC bus.

Cancellation of After School Activities

A decision will be made early in the afternoon regarding contests, evening programs and practices.

Tornado Watch

All students will remain in school until regular dismissal. Parents may pick up their own children, but they may not pick up other children unless there is written permission on file for that to take place. For a TORNADO WATCH AFTER SCHOOL HOURS, after school activities may continue depending on the time of the expiration of the watch and the judgment of the coach or adult sponsor of the activity.

Tornado Warning

Students will be instructed to take shelter in designated areas with teachers and remain until the warning is lifted and the ALL CLEAR is announced. If necessary, after school busing will be delayed until the warning ends. For a TORNADO WARNING AFTER SCHOOL HOURS, club sponsors and coaches will seek the safest shelter and remain there until the warning is lifted.

Chromebooks

Sixth grade KCMS students will be issued a Chromebook at our open house on August 20th. Seventh and Eighth grade students will return to school with the Chromebook they were issued last school year. Each Chromebook has a charger and a protective carrying case. Please ensure that your student is taking good care of this device, keeping it in the protective case, and charging it on a nightly basis.

Students who would like to use their own device throughout the school day are welcomed to do so. Students who elect this option must still use their @kentcityschools.org login to ensure that they have the same content filtering as school issued Chromebooks.

New MS Exploratory Classes

Students at Kent City Middle School will once again rotate through Art, Physical Education, and Computers for their morning exploratory classes. However, there will be some new options offered as well.

Band: Band will be a year-long option for 7th and 8th grade students. All 6th grade students will take a trimester of band as part of their afternoon exploratory classes.

7th and 8th grade students who aren't in band and all 6th grade students will take the following classes:

Weather and Climate: Mrs. Sutton will be exploring geography with a focus on weather and climate. This course will include hands-on activities to help students experience the content first-hand.

Creative Writing: Ms. Stricklin will be working with seventh graders in a new creative writing elective. This course will include writing games, poetry, journalism and many other opportunities for students to explore their creativity through writing. Students will also gain inspiration by reading various types of writing.

Cell Phone Policy

MS and HS students are allowed to use cell phones before and after school. During school hours phones are expected to be turned off and in the student's locker. Capturing images and video at school is prohibited.

NWEA MAP Testing

We'll continue monitoring student progress with the NWEA MAP Test with each grade level taking the English and Math tests and the 8th grade also taking the Science test.

MTSS/PBIS

Our PBIS program continues to grow starting again with our First Four Days. Students will spend time each day with their "Family" to help build relationships and belonging for each student. This will continue throughout the year with our Family Cup competitions, reward days, and our school store. Students can purchase items at the school store using Eagles coins they earn by showing appropriate behaviors throughout the school day.

Onward and Upward!

In many ways, 2023-24 was a learning year for many of our varsity teams. A number of our teams featured underclassmen in key roles, and it showed, as the Eagles only captured two conference championships (football and volleyball), one Regional championship (girls track and field), and one team qualified for the state finals (girls xc). Individually, Kent City student athletes earned 60 all-conference selections (38 1st Team, 8 2nd Team, & 14 Honorable Mention) and 9 all state selections.

In addition to the experience gained last year, the move by the CSAA to go back to divisions will also offer the Eagles more opportunity to compete for conference championships. Instead of 11 teams, Kent City will be in the White Division along with Central Montcalm, Lakeview, Morley Stanwood, and White Cloud for baseball, basketball, cross-country, softball, track and field, and volleyball. Our bowling, golf, soccer, and wrestling teams will compete in the Blue Division, while the bigger schools will be in the Red Division.

Another exciting change for 2024-25 is our move to digital forms. Instead of stacks of paperwork that we have to constantly chase down in the preseason, these forms will be accessible via your PowerSchool Parent Portal Account. All of this information can be completed on your phone or computer and will allow us to track important information and better prepare for emergencies. As the beginning of the 2024-25 season gets closer, we will be helping everyone complete these mandatory forms that are designed for our student-athletes' safety and open lines of communication. Prior to competing for the Eagles, this information will need to be completed!

We are looking for a resurgence by the Eagles in 2024-25 as we use the many lessons learned from last season, to continue on our quest for EXCELLENCE!

The Kent City School District participates in the National School Lunch Program (NSLP), School Breakfast Program (SBP) and federally funded After School Snack Program (CACFP) & Summer Lunch Program (SLP). This allows us to serve breakfast, lunch and snack at each school daily and food during the summer break.

Kent City is excited to continue to offer free breakfast and lunch to all students thanks to the Michigan Healthy School Meals Program. Even though meals will be provided for free, it is important for families to continue sharing confidential household income information in order for our schools to receive full access to federal and state funding for educational programs that our students are entitled to.

As a household, you are responsible for completing the Education Benefits Form. Without this information, our district could lose important state funding for educational programs that students are entitled to. You can find this form at Kentcity.familyportal.cloud. Through this link, you will fill out this form and deposit money to your child's account for ala carte purchases. This site can be found on our website under the Food Service link. Education Benefits Forms are also used in determining P-EBT payments, fee waivers and Title I funding for the school. Online is the safest and quickest way to fill out the form. Paper forms will be available in each building's office. All Education Benefits Forms are confidential. You only need to fill out one form per family.




One milk is included with each Breakfast & lunch. Additional Milk can be purchased for \$.50 each. Milk with a sack lunch from home is NOT free.

■ STATE/FEDERAL REGULATIONS

Directory Information

The Family Educational Rights and Privacy Act (FERPA), a Federal law, requires that Kent City Community Schools with certain exceptions, obtain your written consent prior to the disclosure of personally identifiable information from your child's education records. However, Kent City Community Schools may disclose appropriately designated "directory information" without written consent, unless you have advised the District to the contrary in accordance with District procedures. The primary purpose of directory information is to allow the Kent City Community Schools to include this type of information from your child's education records in certain school publications. Examples include: a play or music program, yearbook, honor roll or other recognition lists; graduation programs or sports activity lists.

Directory information, which is information that is generally not considered harmful or an invasion of privacy if released, can also be disclosed to outside organizations without a parent's prior written consent. Outside organizations include, but are not limited to, companies that manufacture class rings or publish yearbooks. In addition, two federal laws require local educational agencies (LEAs) receiving assistance under the *Elementary and Secondary Education Act of 1965* (ESEA) to provide military recruiters, upon request, with the following information – names, addresses and telephone listings – unless parents have advised the LEA that they do not want their student's information disclosed without their prior written consent.

If you do not want Kent City Community Schools to disclose directory information from your child's education records without your prior written consent, you must notify the District in writing by November 1, 2024. Notification should be made at the school building your child attends.

Kent City Community Schools has designated the following information as directory information: Student's name, address, telephone number, date/place of birth, major field of study, participation in officially recognized activities and sports; height/weight if member of athletic team, dates of attendance; Date of graduation; awards received; honor rolls; studentships, photographs or videos of students participating in school activities, events or programs.

Asbestos Management Plan

Kent City Community Schools are required by the Asbestos Emergency Response Act to make annual notification of the availability of the Asbestos Management Plan. The school has conducted an extensive survey of all buildings. Based on the findings of the inspection, a comprehensive management plan has been created. The plan details the response actions regarding asbestos containing materials in the buildings. This plan is available during normal business hours, for inspection at our offices without cost or restriction. Please contact Doug Weston, Director of Operations, (616) 678-7714.

Homeless Services

If your family finds yourself in a homeless situation including living in a shelter, motel, vehicle, campground, on the street, or other inadequate accommodation, or doubled up with friends/relatives because you cannot afford housing, please contact Sarah Earnest, McKinney-Vento Homeless Liaison, through any of the school offices or calling 616-678-7714.

Students with Disabilities

The Individuals with Disability Education Act (IDEA) requires all children (0-25) with disabilities residing in the State of Michigan, including children with disabilities who are homeless children or are wards of the State, and children with disabilities attending private schools, regardless of the severity of their disability, and who are in need of special education and related services, are identified and evaluated. If you feel your child may have a disability that prohibits s/he from succeeding educationally, please contact your child's building principal or the Special Education Office at 616-678-4219.

Freedom of Information Act (FOIA)

It is the public policy of this state that all persons, except those persons incarcerated in state or local correctional facilities, are entitled to full and complete information regarding the affairs of government and the official acts of those who represent them as public officials and public employees, consistent with this act. The people shall be informed so that they may fully participate in the democratic process. In compliance with requests for public records in accordance with the Michigan FOIA, Kent City Community Schools will process all FOIA requests in accordance with the requirements of FOIA and the school policies and procedures. FOIA requests should be made in writing and addressed to the FOIA Coordinator, Kent City Schools, 200 N. Clover St., Kent City, MI 49330.

Notification of Rights for Elementary and Secondary Schools

The Family Educational Rights and Privacy Act (FERPA) affords parents and students who are 18 years of age or older ("eligible students") certain rights with respect to the student's education records. These rights are:

- The right to inspect and review the student's education records within 45 days after the day Kent City Community Schools receives a request for access.
- Parents or eligible students who wish to inspect their child's or their education records should submit to the school principal [or appropriate school official] a written request that identifies the records they wish to inspect. The school official will make arrangements for access and notify the parent or eligible student of the time and place where the records may be inspected.
- The right to request the amendment of the student's education records that the parent or eligible student believes are inaccurate, misleading, or otherwise in violation of the student's privacy rights under FERPA.
- Parents or eligible students who wish to ask Kent City to amend their child's or their education record should write the school principal and clearly identify the part of the record they want changed, and specify why it should be changed. If the school decides not to amend the record as requested by the parent or eligible student, the school will notify the parent or eligible student of the decision and of their right to a hearing regarding the request for amendment. Additional information regarding the hearing procedures will be provided to the parent or eligible student when notified of the right to a hearing.
- The right to provide written consent before the school discloses personally identifiable information (PII) from the student's education records, except to the extent that FERPA authorizes disclosure without consent.
- One exception, which permits disclosure without consent, is disclosure to school officials with legitimate educational interests. The criteria for determining who constitutes a school official and what constitutes a legitimate educational interest must be set forth in the school's or school district's annual notification for FERPA rights. A school official typically includes a person employed by the school or school district as an administrator, supervisor, instructor, or support staff member (including health or medical staff and law enforcement unit personnel) or a person serving on the school board. A school official also may include a volunteer, contractor, or consultant who, while not employed by the school, performs an institutional service or function for which the school would otherwise use its own employees and who is under the direct control of the school with respect to the use and maintenance of PII from education records, such as an attorney, auditor, medical consultant, or therapist; a parent or student volunteering to serve on an official committee, such as a disciplinary or grievance committee; or a parent, student, or other volunteer assisting another school official in performing his or her tasks. A school official typically has a legitimate educational interest if the official needs to review an education record in order to fulfill his or her professional responsibility.

Upon request, the school discloses education records without consent to officials of another school or school district in which a student seeks or intends to enroll, or is already enrolled if the disclosure is for purposes of the student's enrollment or transfer. [NOTE: FERPA requires a school or school district to make a reasonable attempt to notify the parent or student of the records request unless it states in its annual notification that it intends to forward records on request or the disclosure is initiated by the parent or eligible student.]

The right to file a complaint with the U.S. Department of Education concerning alleged failures by Kent City to comply with the requirements of FERPA. The name and address of the Office that administers FERPA are:

Title I

As an educational institution that receives funds under Title I, Kent City Community Schools is required to notify all parents that you may request information regarding the professional qualifications of your child's teacher including:

- Whether the teacher has met state qualifications and licensing criteria for the level(s) and subject areas in which the teacher provides instruction.
- Whether the teacher is teaching under emergency or other provisional status through which state qualification or licensing criteria have been waived.
- The baccalaureate degree major of the teacher and any other graduate certification or degree held by the teacher and the field of discipline of the certification or degree.
- Whether your child is provided services by Title I paraprofessionals and, if so, their qualifications.


