Adverse weather conditions and other emergency situations may make it necessary to cancel school, to delay the beginning of school, or to send students home early. Our superintendent and transportation department is out early in the morning to check road conditions. They are in contact with neighboring school districts. The final decision is made by the superintendent. Whenever it is necessary to delay or close school, notice will be communicated through **TV channels 8, 13 and 17; the district & building Facebook pages; and the district website www.kentcityschools.org.**

In the event of a two hour delay:

- * There will be no a.m. preschool.
- * Buses will pick up two hours later than normal.
- * All classes will start two hours later than normal.
- * No morning breakfast will be served.
- * No 1st Session KCTC bus.

Cancellation of After School Activities

A decision will be made early in the afternoon regarding contests, evening programs, and practices.

Tornado Watch

All students will remain in school until regular dismissal. Parents may pick up their own children, but they may not pick up other children unless there is written permission on file for that to take place. For a **TORNADO WATCH AFTER SCHOOL HOURS**, after school activities may continue depending on the time of the expiration of the watch and the judgment of the coach or adult sponsor of the activity.

Tornado Warning

Students will be instructed to take shelter in designated areas with teachers and remain until the warning is lifted and the **ALL CLEAR** is announced. If necessary, after school busing will be delayed until the warning ends. For a **TORNADO WARNING AFTER SCHOOL HOURS**, club sponsors and coaches will seek the safest shelter and remain there until the warning is lifted.

The very heart of what we do each day is Service. We are grateful for the opportunity to serve your families' school meal needs and strive to serve delicious, well-balanced meals in a safe, cheerful, and caring atmosphere.

Welcome to the 2025 – 2026 school year!

The Kent City School District participates in the National School Lunch Program (NSLP), School Breakfast Program (SBP), and federally-funded After School Snack Program (CACFP) & Summer Lunch Program (SLP). This allows us to serve breakfast, lunch, and snack at each school daily and food during the summer break.

As of the writing of this communication, we are still waiting for confirmation from the State of Michigan if school meals will be free to everyone this year. IF the State of Michigan approves free breakfast and lunch for all students: Kent City will participate in the Community Eligibility Provision (CEP) under the National School Lunch and School Breakfast Programs. This means every student can enjoy a healthy breakfast and lunch at NO CHARGE. Even though meals will be provided for free, it is important for families to continue sharing confidential household income information in order for our schools to receive full access to federal and state funding for educational programs that our students are entitled to.

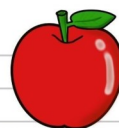
As a household, you are responsible for completing the Education Benefits Form. Without this information, our district could lose important state funding for educational programs that students are entitled to. You can find this form at [Kentcity.familyportal.cloud](https://kentcity.familyportal.cloud). Through this link, you will fill out this form and deposit money to your child's account for ala carte purchases. This site can be found on our website under the Food Service link. Education Benefits Forms are also used in determining Sun Buck payments, fee waivers and Title I funding for the school. Online is the safest and quickest way to fill out the form. However, paper forms will be available in each building's office. All Education Benefits Forms are confidential. You only need to fill out one form per family.

Lunch Menus are located under each school's communication tab. Please know these menus may be subject to change.

One milk is included with each breakfast & Lunch. Additional milk can be purchased for \$.50 each. Milk with a sack lunch from home is NOT free.

We look forward to welcoming your children to the cafeteria this fall.

Chromebooks

New for 2025–26: District-Issued Chromebook Required for All Students

Beginning this school year, all students will be **required to use a school-issued Chromebook** for their coursework and classroom activities. **Personal devices such as laptops or tablets will no longer be permitted** for use during the school day. This change will help us provide a more consistent, secure, and supported digital learning experience for all students.

Most students will still have the Chromebook that was issued during the 2024–25 school year, and they should bring it with them, fully charged, on the first day of school. Chromebooks will be issued to incoming 6th graders at the Open House on August 20th. If your student no longer has their Chromebook or if it is damaged, please contact the school office as soon as possible, so we can help with a replacement.

We appreciate your support as we make this transition. Our goal is to ensure every student has the tools they need for success in and out of the classroom.

Cell Phones at KCHS

In alignment with new legislation passed in Michigan and our ongoing commitment to creating a focused, distraction-free learning environment, students will be expected to keep their cell phones stored in their lockers throughout the school day.

Under Michigan's new law, school districts are encouraged to limit or restrict student cell phone use during instructional time. At Kent City Middle and High School, this means cell phones may not be used in any classroom at any time, unless explicitly permitted by a teacher for educational purposes.

We understand that cell phones are a part of students' daily lives, but they are a frequent source of distraction and disruption. This policy is designed to support student engagement, learning, and well-being.

Consequences for cell phone use during class are as follows:

- **First Offense:** The phone will be confiscated and may be picked up by the student at the end of the school day.
- **Second Offense:** The phone will be confiscated and must be picked up by a parent or guardian. The student will be issued a lunch detention.
- **Third or Subsequent Offenses:** A meeting will be held with the student, parent/guardian, and an administrator to develop an individualized plan to ensure future compliance with the policy. The student will be issued two lunch detentions or an after-school detention.

We ask families to help reinforce these expectations and contact the main office if they need to reach their student during the school day.

Thank you for partnering with us to support a positive and productive school environment.

Capturing Images and Recording – Student Expectations

To protect the privacy and safety of everyone in our school community, students are not permitted to use cell phones or other personal devices to capture photos, videos, or audio recordings of any student, staff member, or other individual during the school day—unless they have express permission from a staff member and those being recorded.

Additionally, using a cell phone or any device to record or take photos in areas where there is a reasonable expectation of privacy—such as bathrooms, locker rooms, or changing areas—is strictly prohibited.

Violations of this policy will be treated seriously and may result in disciplinary action. We ask for your partnership in reinforcing these expectations at home and helping our students understand the importance of respecting others' privacy and dignity.

New Testing Policy for Online Courses

As part of our continued commitment to academic integrity, all students enrolled in online courses through Kent City Virtual Academy will now be required to take tests and unit assessments in person at the school building. This is a new policy starting with the 2025–26 school year.

Previously, students could complete all coursework from home, including tests. However, in-person testing will now be required to ensure the validity of assessments and to support student success. Specific testing times and procedures will be shared by the online classroom staff as the school year begins.

Thank you for your understanding and support as we implement this change to strengthen the integrity and quality of our online learning program.

Directory Information

The *Family Educational Rights and Privacy Act* (FERPA), a Federal law, requires that Kent City Community Schools with certain exceptions, obtain your written consent prior to the disclosure of personally identifiable information from your child's education records. However, Kent City Community Schools may disclose appropriately designated "directory information" without written consent, unless you have advised the district to the contrary in accordance with district procedures. The primary purpose of directory information is to allow the Kent City Community Schools to include this type of information from your child's education records in certain school publications. Examples include: a play or music program, yearbook, honor roll or other recognition lists, graduation programs or sports activity lists.

Directory information, which is information that is generally not considered harmful or an invasion of privacy if released, can also be disclosed to outside organizations without a parent's prior written consent. Outside organizations include, but are not limited to, companies that manufacture class rings or publish yearbooks. In addition, two federal laws require local educational agencies (LEAs) receiving assistance under the *Elementary and Secondary Education Act of 1965* (ESEA) to provide military recruiters, upon request, with the following information – names, addresses and telephone listings – unless parents have advised the LEA that they do not want their student's information disclosed without their prior written consent.

If you do not want Kent City Community Schools to disclose directory information from your child's education records without your prior written consent, you must notify the district in writing by November 1, 2024. Notification should be made at the school building your child attends.

Kent City Community Schools has designated the following information as directory information: student's name, address, telephone number, date/place of birth, major field of study, participation in officially recognized activities and sports, height/weight if member of athletic team, dates of attendance, date of graduation, awards received, honor rolls, studentships, photographs or videos of students participating in school activities, events or programs.

Asbestos Management Plan

Kent City Community Schools are required by the Asbestos Emergency Response Act to make annual notification of the availability of the Asbestos Management Plan. The school has conducted an extensive survey of all buildings. Based on the findings of the inspection, a comprehensive management plan has been created. The plan details the response actions regarding asbestos containing materials in the buildings. This plan is available during normal business hours, for inspection at our offices without cost or restriction. Please contact Doug Weston, Director of Operations, (616) 678-7714.

If your family finds yourself in a homeless situation including living in a shelter, motel, vehicle, campground, on the street, or other inadequate accommodation, or doubled-up with friends/relatives because you cannot afford housing, please contact Sarah Earnest, McKinney-Vento Homeless Liaison, through any of the school offices or calling (616) 678-7714.

Students with Disabilities

The Individuals with Disability Education Act (IDEA) requires all children (0-25) with disabilities residing in the State of Michigan, including children with disabilities who are homeless children or are wards of the state, and children with disabilities attending private schools, regardless of the severity of their disability, and who are in need of special education and related services, are identified and evaluated. If you feel your child may have a disability that prohibits s/he from succeeding educationally, please contact your child's building principal or the Special Education Office at (616) 678-4219.

Freedom of Information Act (FOIA)

It is the public policy of this state that all persons, except those persons incarcerated in state or local correctional facilities, are entitled to full and complete information regarding the affairs of government and the official acts of those who represent them as public officials and public employees, consistent with this act. The people shall be informed so that they may fully participate in the democratic process. In compliance with requests for public records in accordance with the Michigan FOIA, Kent City Community Schools will process all FOIA requests in accordance with the requirements of FOIA and the school policies and procedures. FOIA requests should be made in writing and addressed to the FOIA Coordinator, Kent City Schools, 200 N. Clover St., Kent City, MI 49330.

Notification of Rights for Elementary and Secondary Schools

The Family Educational Rights and Privacy Act (FERPA) affords parents and students who are 18 years of age or older ("eligible students") certain rights with respect to the student's education records. These rights are:

- The right to inspect and review the student's education records within 45 days after the day Kent City Community Schools receives a request for access.
- Parents or eligible students who wish to inspect their child's or their education records should submit to the school principal [or appropriate school official] a written request that identifies the records they wish to inspect. The school official will make arrangements for access and notify the parent or eligible student of the time and place where the records may be inspected.
- The right to request the amendment of the student's education records that the parent or eligible student believes are inaccurate, misleading, or otherwise in violation of the student's privacy rights under FERPA.
- Parents or eligible students who wish to ask Kent City to amend their child's or their education record should write the school principal and clearly identify the part of the record they want changed, and specify why it should be changed. If the school decides not to amend the record as requested by the parent or eligible student, the school will notify the parent or eligible student of the decision and of their right to a hearing regarding the request for amendment. Additional information regarding the hearing procedures will be provided to the parent or eligible student when notified of the right to a hearing.
- The right to provide written consent before the school discloses personally identifiable information (PII) from the student's education records, except to the extent that FERPA authorizes disclosure without consent.
- One exception, which permits disclosure without consent, is disclosure to school officials with legitimate educational interests. The criteria for determining who constitutes a school official and what constitutes a legitimate educational interest must be set forth in the school's or school district's annual notification for FERPA rights. A school official typically includes a person employed by the school or school district as an administrator, supervisor, instructor, or support staff member (including health or medical staff and law enforcement unit personnel) or a person serving on the school board. A school official also may include a volunteer, contractor, or consultant who, while not employed by the school, performs an institutional service or function for which the school would otherwise use its own employees and who is under the direct control of the school with respect to the use and maintenance of PII from education records, such as an attorney, auditor, medical consultant, or therapist; a parent or student volunteering to serve on an official committee, such as a disciplinary or grievance committee; or a parent, student, or other volunteer assisting another school official in performing his or her tasks. A school official typically has a legitimate educational interest if the official needs to review an education record in order to fulfill his or her professional responsibility.

Upon request, the school discloses education records without consent to officials of another school or school district in which a student seeks or intends to enroll, or is already enrolled if the disclosure is for purposes of the student's enrollment or transfer. [NOTE: FERPA requires a school or school district to make a reasonable attempt to notify the parent or student of the records request unless it states in its annual notification that it intends to forward records on request or the disclosure is initiated by the parent or eligible student.]

The right to file a complaint with the U.S. Department of Education concerning alleged failures by Kent City to comply with the requirements of FERPA. The name and address of the Office that administers FERPA are:

Title I

As an educational institution that receives funds under Title I, Kent City Community Schools is required to notify all parents that you may request information regarding the professional qualifications of your child's teacher including:

- Whether the teacher has met state qualifications and licensing criteria for the level(s) and subject areas in which the teacher provides instruction.
- Whether the teacher is teaching under emergency or other provisional status through which state qualification or licensing criteria have been waived.
- The baccalaureate degree major of the teacher and any other graduate certification or degree held by the teacher and the field of discipline of the certification or degree.
- Whether your child is provided services by Title I paraprofessionals and, if so, their qualifications.

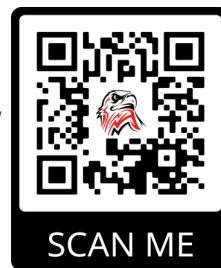
